If an intermediary, a shareholders' association, a voting rights advisor pursuant to Section 134a of the German Stock Corporation Act (AktG) or a person equivalent to theses pursuant to Section 135 para 8 of the German Stock Corporation Act (AktG) is not prepared to act as proxy, the proxies of the Company shall be authorized to act in accordance with the instructions. The last withdrawal of a declaration received in due time shall be decisive. If an individual vote is held on an agenda item instead of a collective vote, the absentee vote or instruction issued for this agenda item shall apply accordingly to each item of the individual vote.

Proxy holders designated by the company can only exercise voting rights for you that have instructions. Proxy holders designated by the company will not implement any orders beyond these.
